REPORT OF THE MANAGER TO THE UNITHOLDERS

DA CHENG SHORT TERM BOND FUND (A SUB-FUND OF DCI INVESTMENT TRUST)

Fund Performance

Da Cheng Short term Bond Fund (the "Sub-Fund") provide a stable income as well as capital growth over the medium to long term by investing in a globally diversified portfolio of debt securities. As of 30 June 2024, the Sub-Fund aggregates a total asset size of approximately USD 12,114,157.

Market Overview

In the first half of 2024, the Federal Reserve kept its interest rate policy unchanged, and the policy rate level remained at the range of 5.25-5.5%. The key to the market's attention and the anchorage of various assets remains the Federal Reserve's interest rate policy and the overall process of U.S. inflation control. In 2024 H1, although the US economy still maintains resilience, but the overall inflation has formed a significant downward trend, the market's focus theme changed from "Higher for longer" to the timing for the Federal Reserve began to cut interest rates and the number of interest rate cuts in 2024 and 2025, according to the overall US macro data, there is a relatively high probability of interest rate cuts in the second half of the year. On the supply side in the market, due to the high financing cost, the net new issuance in the market is still negative, the proportion of floating rate bond issuance increased significantly.

Affected by the volatility of long-end interest rates, short-duration strategies performed better than long-duration strategies in the first half of the year, the yield on the 10-year Treasury rose to 4.4% from 3.88%, the total return of the global dollar bond index provided a negative return for -0.71% while the return of 1-3-year duration strategy returned 1.41%, and long-term strategy still did not get a positive return. In comparison, the short-duration strategy performed better than the long-term strategy in the first half of the year.

Outlook

We believed that the overall fixed income asset category can still provide relatively stable investment returns in the second half of 2024. For the high policy rate remained, Bond asset not only can obtain relatively high coupon, but also can obtain capital gains in the future interest rate reduction cycle, from the appreciation of bond prices. However, since the market's expectation of the number of interest rate cuts in the United States in the second half of the year will greatly affect the volatility of long-end interest rates, we believe that in the second half of the year, before the real interest rate cuts, the trading value of long-end or long-duration strategies is relatively more prominent.

Duration control will be an important element on the investment side. According to current market expectations, the number of rate cuts this year will be between one and two. With the US interest rate cut coming, the dollar index may fall slightly. In addition, a major concern factor in the United States in the second half of the year will be the election, The Presidential election may affect the US politics to drive market focus as November approaches and it may affect the future macroeconomic state of the United States and thus affect the overall future monetary and interest rate policies. Focusing on short-term, high-quality, investment-grade bonds would still be a better defense option in 2024.
